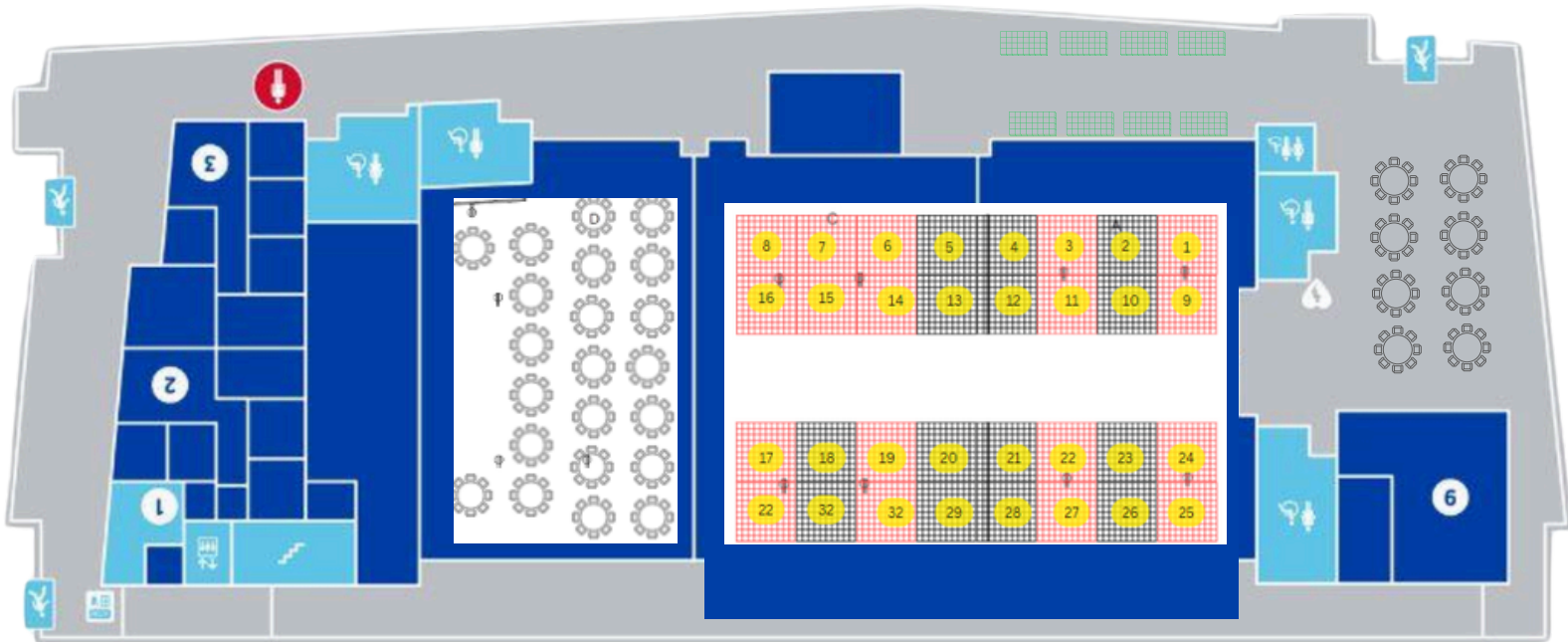

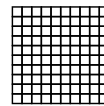

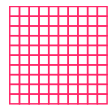
Food Table



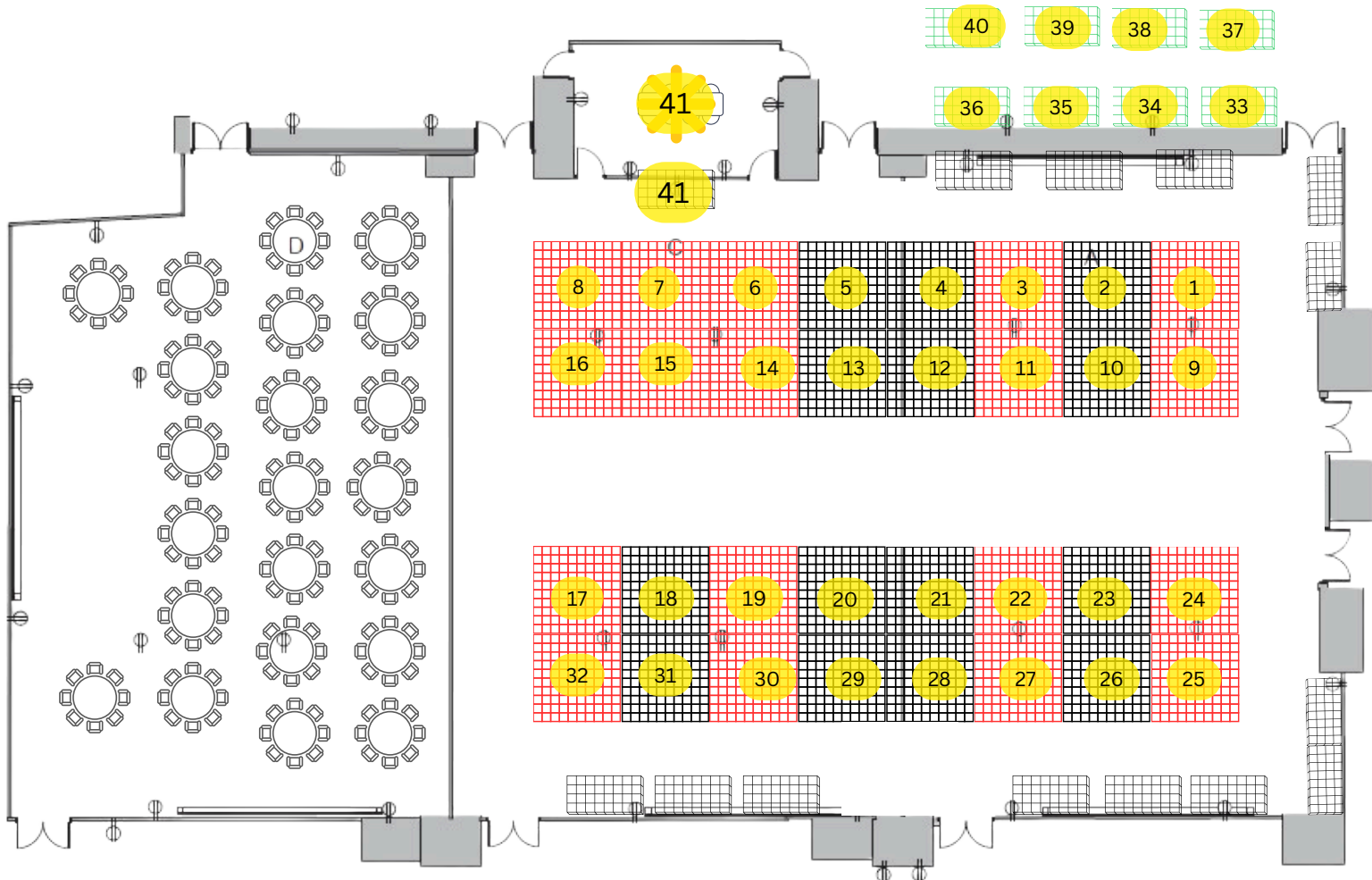

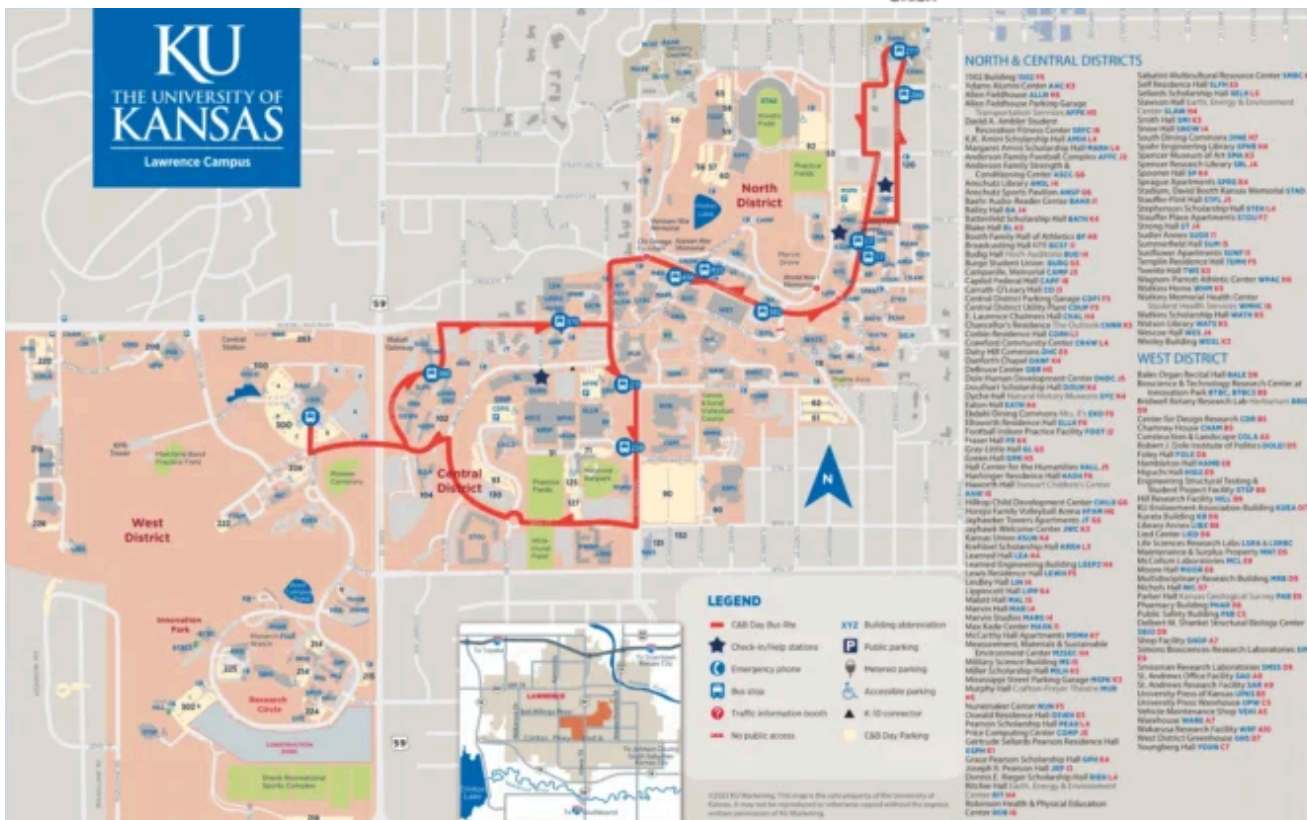
